RE: **RFP for Internal Wiring**

RFP 21-1

These addenda, together with the original RFP and previous addenda shall form the complete request for proposals. This addendum sets forth only the changes and additions, which are to be made in the original RFP. The original documents remain in full force and effect except as specifically modified in these addenda.

Post Pre-Proposal Meeting Questions:

Q1: I am looking at a previous project, that we bid. In that project the specifications called for Plenum rated cable. I do not see the requirement for Plenum cable in these specifications. I believe there are some portions on the building that are plenum spaces. Do you want to clarify the requirement for Plenum rated cable.

A1: RFP 21-1 Internal Wiring III under "Wall Drops" - states:

Wall drops: Install any necessary Cat6 wiring and hardware and raceway to support additional identified wall locations at the school site. Each identified drop location requires 2 white Cat 6 cables, raceways, boxes, face plates, and 10' slack loops at telecommunications room and 15' slack loops above ceiling at destination. Termination locations will typically be a foot or two below a drop ceiling, and raceway from ceiling to location is to be provided if not already in place.

Connections may return to one of 6 IDF/MDF closets at the school site, terminating to existing modular patch panels or compatible (vendor supplied) hardware if existing panels are full.

Cables and patch panels shall be labeled according to district specifications, and as-built documentation delivered indicating cable labels at destination locations.

District requires unit pricing per drop, installed, including connectors, raceway and patchdown to appropriate pane. A drop consists of two cable runs to a location, described above. Please bid a unit price for a ceiling drop and a price for a wall drop separately.

Wiring pathways do not include plenum spaces.

This addendum makes the following changes to clarify Q1:

1. Changes RFP-21-1 Internal Wiring/Request for Proposal for Internal Structured Network Cabling, section III, under section **Wall Drops**, insert “**Bidding Instructions and Guidance:**” between sentence “Cables and patch panels shall be labeled according to district specifications, and as-built documentation delivered indicating cable labels at destination locations.” and sentence “District requires unit pricing per drop, installed, including connectors, raceway and patchdown to appropriate pane. “
2. Changes RFP-21-1 Internal Wiring/Request for Proposal for Internal Structured Network Cabling, section III, under section **Wall Drops** to fix misspelling of separately in the sentence “A drop consists of two cable runs to a location, described above. Please bid a unit price for a ceiling drop and a price for a wall drop **separatly.**” Replace “separatly” with “separately”.
3. Changes RFP-21-1 Internal Wiring/Request for Proposal for Internal Structured Network Cabling, section III, under section “**Wall Drops:**” Replaces “**Wiring pathways do not include plenum spaces.**” with
with
“The district believes there are no plenum spaces required for wiring pathways. Bidders are to include a per-drop price for each Cat6A (Ceiling) and Cat 6 (Wall) non-plenum and for each Cat6A (Ceiling) and Cat 6 (Wall) plenum run.”
