Fern Ridge School District is currently seeking applicants for a one year temporary, 1.0 FTE TOSA (Autism/Behavior Specialist) responsible for secondary behavior specialist duties, K-12 autism specialist duties and case manager for students attending out of district placements.

**Job Description:** The behavior and autism specialist will complete evaluations, assessments, instruction and curriculum modifications using research/evidence based practice to students with Autism Spectrum Disorder (ASD) ages five through twenty-one and identified behavior supports for students for students in our middle school and high school. This TOSA positions supports school teams, families and other support staff eligible for Special Programs services through consultation, technical assistance, modeling of best practice instructional techniques and workshops. In addition, this position case manages students on IEPs that are placed in out of district programs as well as administers the extended assessment for state testing.
