- (b) Provide appropriate instructional facilities, materials, equipment, and services which support the school district, program and course goals;

Each building in the Fern Ridge School District will maintain a media center/library with appropriate materials and equipment. Staff are assigned to each space and will share with building administration any needs they have in order to ensure services that support the district program and goals may be achieved.

(c) Assign responsibilities to certificated media specialists and other personnel for the development, implementation, maintenance, and supervision of media services;

The FRSD does not have certificated media specialists. However, each building has a Classified employee assigned to the space with a job title of "Media Specialists."

(d) Organize media services and materials required for the achievement of district and building media program goals; and

Oversight by building principals and media specialists

(e) Evaluate district and school media programs.

Done every two years by building principals

- (2) School Media Services: The school district shall provide in each school a media program consistent with district, program and course goals which:
- (a) Provides an organized media center with materials, equipment and services supervised by appropriate certificated personnel;

The program is overseen and supervised by licensed classroom teachers who provide instruction and input to the program goals, by Classified Media Specialist employees assigned to each building, and supervised by licensed administrators.

(b) Identifies instructional activities designed to achieve media skills goals; and

At the elementary school level this is accomplished through classroom activities, and activities are planned and instruction given by classroom teachers. The media/aide/assistant helps with the standard of "reading for enjoyment", through assisting with library checkout and reading to the students. At the Middle School and High School level instructional activities are delivered within individual courses that are targeted at the achievement of media skills goals and media standards.

- (c) Includes instruction that addresses the ability of each student to:
- (A) Locate and retrieve organized print and non print media;
- (B) Use media to record and express ideas and knowledge; and
- (C) Listen to, view, interpret and analyze media materials.
- (3) In determining whether the assignment of certificated media and other staff is appropriate, the following shall be considered:
- (a) The district, program and course goals of the media services program;
- (b) The number of schools, students and staff to be served;

(c) The access students and staff have to media services defined in the media program;

To be coordinated by building principals

(d) The number, certification and training of personnel assigned to media program responsibilities including specialists, teachers and aides;

EHS: One full-time Media Specialist

FRMS: One full-time Media Specialist.

Elementary Schools: 3.25 hour Media Specialist split between both schools.

(e) The extent to which staffing patterns vary from general statewide practice; and

Unknown how we vary from statewide practice, although through informal discussions I believe we are better than some, and not as good as others. Any time the FRSD has additional state school funds to consider adding FTE, A certified Media specialist is always something that should be at least considered, amongst a wide range of needs from more classroom teachers, administrators, classified staff, counselors, P.E., music, art, etc....

(f) The extent to which the media program enables students to attain instructional goals.

The FRSD media program enables students to fully attain our identified instructional goals.
