

# McKinney-Vento Homeless Assistance

---

**If you live in any of the following situations**, you may qualify for certain rights or protections under the McKinney-Vento Assistance Act.

- shelter or transitional housing
- motel or hotel
- sleeping in a vehicle, tent, RV, public space, campground
- staying with friends or family due to hardship, eviction, foreclosure

**Eligible students have the right to:**

- stay in the school they were attending when they lost housing, or enroll in their neighborhood school
- enroll in school immediately, even if they don't have their documentation or immunizations
- access the same programs, services and appropriate supports as all students
- receive free school meals

**The liaison helps students and families in the following ways:**

- help students register for and enroll in school
- set up transportation for students to and from school
- make referrals to local service providers
- help navigate systems
- help students with basic needs, or refer to agencies that help
