

SAW LOGS and/or FIREWOOD BID(S)

The Fern Ridge School District will accept sealed bids for the below material. All bids are to be delivered to the District Office, 88834 Territorial Road, Elmira, OR 97437 on or before **4:00 P.M. on Monday, May 2nd, 2022.**

Bids will be opened at 10:00 A.M. on Tuesday, May 3rd, 2022, in the Board room of the District Office.

1) **BIDDING**

- Be sure your sealed bid is signed with your name, complete address and phone number.
- Bid forms must be filled out in their entirety.

2) **PAYMENTS**

- Advance cash payment is required upon bid acceptance.

3) **GUIDELINES**

- Self-loading truck required for removal of saw logs.
- No milling of material allowed on District property (cutting of firewood not allowed during school hours).
- Saw logs must be removed within two weeks of bid acceptance.
- Firewood logs must be removed within four weeks of bid acceptance.
- Purchaser shall indemnify and hold seller harmless for any worker's compensation costs related to the timber. It is also understood that there is no employee-employer relationship between Seller and Purchaser, and any subcontractor of the Purchaser.
- Purchaser is responsible to comply with, and assure compliance with, all Occupational Safety and Health Act (OSHA) requirements for the health and safety of purchaser and purchaser's employees, if any, including provision for danger of logs.
- Purchaser responsible to remove ALL usable material.

The Fern Ridge School District reserves the right to accept or reject any or all bids.

- 6 Fir logs suitable for milling into lumber (approximately 40 foot in length for an approximate total of 4500 board feet of material).

Minimum bid \$750

- Firewood logs (Approximately 2 ½ cords).

Minimum bid \$50

The Seller and Purchaser mutually agree that this contract is subject to the following provisions:

The Purchaser will completely perform his/her obligations under this contract within two weeks for the Saw Logs and no later than four weeks for the Firewood Logs.

Requirements:

- Upon written notice by the Seller, to the Purchaser that he/she is not in compliance with one or more conditions of this contract, all operations must be suspended and may not be resumed without written authorization. The decision of the Seller as to whether the Purchaser is in compliance with the terms of this contract shall be final.
- No skidding or piling of wood products on public roads or right-of-ways is allowed.
- The Purchaser agrees to assume all liability for any damage or injury to persons or property, real or personal, resulting from the Purchaser's operations under this contract and will hold the Seller harmless for the same.
- This contract cannot be assigned in whole or in part.
- All modifications to this contract must be in writing, signed by the parties hereto.
- Purchaser shall indemnify and hold seller harmless for any worker's compensation costs related to the timber on the premises. It is also understood that there is no employee-employer relationship between Seller and Purchaser, and any subcontractor of the Purchaser.
- Purchaser is responsible to comply with, and assure compliance with, all Occupational Safety and Health Act (OSHA) requirements for the health and safety of purchaser and purchaser's employees, if any, including provision for danger of logs.
